#### **GENERAL INFORMATION AND TEST RULES**

1. Entry Fee is: \$60.00 payable in US dollars. Entry fee includes a \$.50 AKC recording fee and \$3.00 event fee. Make checks payable to EDOC.
2. Closing date for entries will be accepted until 5:00 PM, Thursday April 6, 2017 after which time entries will not be accepted, canceled, altered or substituted.
3. For other delivery options call test secretary for instructions. No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.
4. A random drawing will take place Thursday, April 6, 2017, at 5 PM, at the office of Carol Reeves, 5258 Green Valley Rd., Oakland, OR 97462 Call or email the Test Secretary for directions to draw site. When the limit is reached, the drawing will continue and an alternate list will be established in the order in which entries are drawn.
5. Mail all entries of dogs that have not earned a TD title, with an original written statement of certification dated within 1 year of the date of the test signed by an approved or provisional tracking judge, with entry and fee to: Carol Reeves, 5258 Green Valley Rd., Oakland, OR 97462. Make checks or money orders payable to EDOC.

6. Only one entry per dog will be accepted. Dogs not holding any tracking dog title will have priority for the draw. Please do not mail additional entries. They will be returned. No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.
7. Acknowledgment of entries will be made as soon as possible after the drawing. If the exhibitor does not receive acknowledgment within a reasonable time please email [topsham@rosenonet.net](mailto:topsham@rosenonet.net) or call 541-459-4966.
8. At the draw four (4) tracks will be set aside per Chapter 1, Section 17d. Test worker is defined as an EDOC Member who served as judge, test chair, test secretary, test committee or tracklayer at any EDOC tracking test in the prior calendar year.
9. All dogs and handlers must be at the Tracking Test area before 7:00 AM on Sunday, April 16th, at which time there will be a drawing for track order. Entrants not present at the time of drawing for tracks may be marked absent and an alternate allowed to run in their place.
10. An alternate list will be maintained for the TD Test. No entry fees will be refunded unless an alternate is present and runs on the absent dog's track. Entry fees of an alternate that does not compete shall be refunded. In the event an accepted entry is absent on the day of the test, the Tracking Test Secretary shall determine if any alternates are present, and the available track(s) shall be assigned in the order in which alternate entries were drawn.
11. Judging will start as soon as the first track has aged the required time.
12. The entry fee will be refunded if either 1) entrant notifies test secretary prior to the draw 1) the entrant notifies the secretary prior to the test and an alternate runs the track, or 2) the dog is an alternate who does not run a track.
13. BITCHES IN SEASON MAY PARTICIPATE under the conditions specified in the AKC Tracking Regulations.
14. The AKC believes the wellbeing of dogs and participants are of paramount importance. In the case of adverse weather conditions, the test could be canceled and rescheduled.
15. EDOC offers each passing dog a wooden plaque with a map of its track.
16. All entrants are responsible for complying with the AKC rules regarding Tracking Tests and other AKC rules referred to in the Tracking Test Rule book.
17. Dogs must be kept on leash at all times. Failure to comply will result in the dog and handler being excused from the test site and the withholding of any awards.
18. This club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.
19. Post Test Lunch: Lunch will be served after the Test at the Test site. Followed by awards. All are invited to attend. A \$5 donation would be appreciated
20. DIRECTIONS TO THE TEST SITE: I-5 Exit 195B (Randy Pape Beltline Hwy.) heading west. Take exit 6 (Hwy. 99) going towards Junction City. Turn left onto Clear Lake Rd (signal). Drive approximately 2.9 miles. Turn right on Lakeview Dr. (Clear Lake Estates). Take 1<sup>st</sup> left onto Edgewater Dr. 28151 Edgewater is on the right. There is no overnight camping on the grounds. This is private property. Please do not arrive prior to 6:45 AM. Hotel information will be included with entry confirmation /judging program.
