### GENERAL INFORMATION AND TEST RULES

1. **Entry Fee:** \$75.00 payable in US dollars. Entry fee includes a \$.50 AKC recording fee and \$3.00 event fee. Make checks payable to EDOC.
2. **Closing Date:** Entries will be accepted until 5:00 PM, Thursday June 16, 2022 after which time entries will not be accepted, canceled, altered or substituted.
3. For other delivery options call test secretary for instructions. Make checks or money orders payable to EDOC. No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.
4. **Drawing for Entries:** This test is limited to 4 dogs. A random drawing will take place Thursday, June 16, 2022, at 5 PM, at the Emerald Dog Obedience Club training facility, 1000 Obie Street, Eugene, OR. Call or email the Test Secretary for directions to draw site. When the limit is reached, the drawing will continue and an alternate list will be established in the order in which entries are drawn.
5. **Notification:** Acknowledgment of entries will be made as soon as possible after the drawing. If the exhibitor does not receive acknowledgment within a reasonable time, please email [cognitivedog1@icloud.com](mailto:cognitivedog1@icloud.com) or 541-603-8941.
6. **Eligibility for Entries:** Preference for entry is dogs who have not yet passed an AKC tracking test. TDU entrants without an AKC tracking title must submit Tracking Certification with entry. Any dog at least 6 months old with AKC # is allowed to enter
7. **Test worker Option:** At the draw one (1) track will be set aside per Chapter 1, Section 17d. Test worker is defined as a person who has an EDOC Test Worker Certificate. Certificate must accompany entry of dog owned or co-owned to be eligible.

8. **Draw for Running Order 6:45 AM:** Handlers must be at the Tracking Test area before 6:45 AM on Sunday, June 26, 2022, at which time there will be a drawing for track order. Entrants not present at the time of drawing for tracks may be marked absent and an alternate allowed to run in their place.
9. **Start of Judging:** Judging will start as soon as the first track has aged the required time. Test Hours: 6:30 am to 4:00 pm.
10. **Refund Policy:** The entry fee will be refunded if either 1) entrant notifies test secretary prior to the draw 1) the entrant notifies the secretary prior to the test and an alternate runs the track, or 2) the dog is an alternate who does not run a track.
11. **Bitches in Season:** Bitches in season may participate in this test. If your bitch is in season, when you arrive at the test site, park your vehicle well away from the other cars and notify the test secretary that your entered bitch is in season. The last track will be reserved for your bitch. If there is more than one bitch in season, a second draw for these bitches will be held. Bitches in season will be allowed to participate only after all other dogs and bitches not in season have been tested. Bitches in season must be kept away from the rest of the entered dogs. Failure to comply with these requirements will result in the handler and dog being excused from the test site and any award withheld.
12. **Directions to Test Site:** *From Eugene:* Hwy 126 West to Veneta/Elmira intersection with Territorial Rd. Go North at signal (right turn). The school district office will be on your left at the corner of Territorial and Warthen Rd.
13. **Extreme Weather Conditions:** The AKC believes the wellbeing of dogs and participants are of paramount importance. In the case of adverse weather conditions, the test could be canceled and rescheduled.
14. **Awards:** EDOC offers each passing dog an EDOC hot/cold cup.
15. **AKC Rules:** All entrants are responsible for complying with the AKC rules regarding Tracking Tests and other AKC rules referred to in the Tracking Test Rule book.
16. **Hospitality:** Limited hospitality may be provided at this test.
17. **IMPORTANT:** Dogs are not allowed on District School Grounds except for this event. Do not visit schools to 'practice' at any time before this test.

**PLEASE NOTE:** There is no overnight parking or camping at the schools. There is a camping at Richardson Park Campground about five miles from Elmira. Nearest hotels are in the Eugene/ Springfield area about 12 miles from Elmira.

Do not arrive prior to 6:30 AM.
